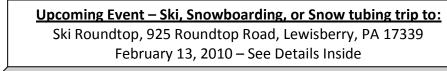

Included in this flier is the Unaudited Report of the Treasurer which provides comparative analysis for the past two years. Similar full report was presented at the General Body Meeting held in December 2009. For the eleven month period ending November 30, 2009, the event related disbursements *exceeded* the receipts by *\$23,168* and for the last two years combined, the Samaj disbursements for the events *exceeded* the receipts by *\$9,993*. Based on the many issues we have identified and the lessons learned during the last couple of years, I strongly believe there is a need for an advisory committee to address the many sensitive issues in our current Bylaws. # **Update of Constitution & Bylaws**

Hament Patel will be leading our efforts to update our Bylaws. We have been operating under the current bylaws that need to be revised as necessary. We also need to look at establishing a few permanent committees such as nominating committee, investment committee and more clearly define the roles of the Executive Committee members. We have grown to a membership consisting of over 550 life members. In order to serve our community better, we need to expand the membership on the Executive Committee and establish the positions of Joint Secretary, Joint Treasurer, Youth Coordinator and expand the number of Member-At-Large positions.

We will be recruiting some of the past presidents to help us in this task. We will look at the current Bylaws of other similar organizations, solicit your input and provide a draft of the proposed changes to you for discussion purposes before any changes are presented at a General Body Meeting.

## **Managing Samaj Assets**

Sly Patel will be leading our efforts to manage our cash resources. We currently have over 550 life members and we need to investigate the establishment of an endowment fund of over \$110,000 to provide income for operating expenses. We currently have over \$150,000 and need to consolidate the number of bank accounts we have and look at the alternatives to investments available such as laddering our CDs and providing optimum protection to our principal.

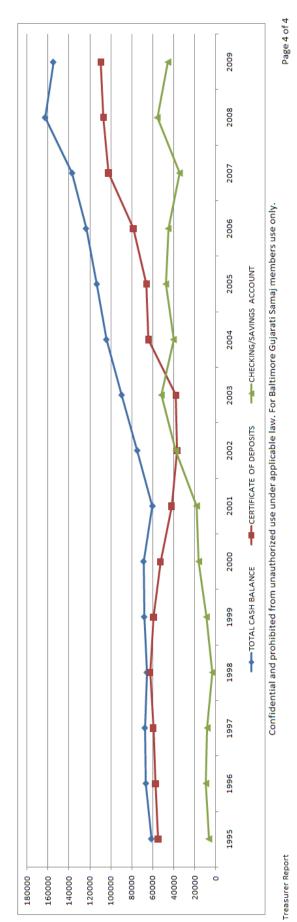
